Games Hire Terms and Conditions:

Hire Duration

The agreed hire period will be agreed in advance and laid out in correspondence.

Payments

The items are hired on an individual basis and unless otherwise agreed, full payment will be taken prior to the event.

Cancellation and or postponement.

If cancellation (for whatever reason) is made more than three months before the event 50% of the games hire charge will be refunded. If cancellation is made within one-month the full balance minus any redeemable costs will be due and charged.

We try to be flexible and if a genuine postponement occurs it may be possible to move the booking at our discretion and without penalty.

Company cancellation:

In the event of the company being unable to fulfil the contract (for whatever reason) the company will endeavour to meet its obligations with a suitable alternative at its own cost. If this is not acceptable or there are no suitable alternatives a full refund will be made to the client.

Covid 19:

If postponement or cancellation is due to increased levels of restriction imposed by government a full refund will be given minus any costs incurred that the company is unable to be reimbursed for. e.g., accommodation, van hire etc. In such circumstances the company will endeavour to have these costs returned and passed back to the client.

Damage or loss of equipment:

We expect all the games to be returned in good condition. Any damage to our games other than general wear and tear will be charged. The charge will be for replacement or repair if this is possible. We reserve the right to bill the client for the repair or full replacement.

Please note: Unless otherwise agreed it is the hirer's responsibility for the safe return of our goods. We suggest you designate a member of your party to oversee the games at the event. Insurance for damage and theft should be covered by the client.

Delivery and Collection

Delivery and collection are made by the company and charged separately from the games hire fee. Please contact for a quote.

Venue:

If the games are not hired with our staff present:

Please ensure there is someone at the venue willing to sign for the hire items.

Please ensure you have informed the venue about the games. It is up to you to make sure the games can be used on the premises. We accept no responsibility if we get to the venue and are told the games are unsuitable. We are very happy to discuss this with the venue in advance to avoid this situation and ensure the smooth running of the day.

Liability

All our games are checked before hire to make sure they are suitable for use and regularly maintained.

If the games are hired with attendants the company (Traditional Fete Games Co Ltd) has full Public Liability insurance which can be viewed at any time.

If the games are not hired with our staff:

Instruction on use of the games will be available on the day.

The hirer is responsible for the safe handling of all equipment.

Some of our games are new versions of vintage games and some are vintage games which will not be covered by recent legislation. The company takes no responsibility for any accident or injury to person or property caused by the use or misuse of the equipment.

Children

Children must be supervised. Please ensure that at least one adult is on hand to instruct and ensure their safety.

Please note: any hire agreed and confirmed verbally or via email correspondence or by written contract acts as a contract to be honoured by both parties.
